UEM SUNRISE RETURNS TO SURABAYA & JAKARTA, INDONESIA FOR SECOND PROPERTY ROADSHOW

Builds on strong demand from UEM Sunrise's introduction of Nusajaya properties to the Indonesian market in mid-2013
