PROPOSED SHARE BUY-BACK

1. INTRODUCTION

On 23 April 2019, the Board of Directors had announced to Bursa Securities that the Company will seek shareholders' approval for the Proposed Share Buy-Back.

The purpose of this Statement is to provide you with the information on the Proposed Share Buy-Back together with the recommendation of the Board and to seek your approval for the ordinary resolution pertaining to the Proposed Share Buy-Back to be tabled at the forthcoming AGM of the Company. The Notice of AGM together with the proxy form are enclosed in the Annual Report 2018.

Shareholders are advised to read and carefully consider the contents of this Statement before voting on the ordinary resolution pertaining to the Proposed Share Buy-Back at the forthcoming AGM.

2. DETAILS OF THE SHARE BUY-BACK

2.1 Quantum

The maximum number of ordinary shares which may be purchased by the Company shall not exceed ten percent (10%) of the issued and paid-up share capital of our Company. Based on the Company's issued and paid-up share capital of RM21,212,361.00 comprising 415,111,350 EF Shares. As at the LPD, the maximum number of EF Shares which may be purchased by the Company pursuant to the Proposed Share Buy-Back shall not exceed 41,511,135 EF Shares. However, the actual number of EF Shares to be purchased and the timing of any purchase pursuant to the Proposed Share Buy-Back will depend on the market conditions and sentiments of Bursa Securities, the availability of financial resources and retained profits of our Company. In addition, the Board will ensure that the purchase of EF Shares will not result in the Company's public shareholding spread falling below the minimum public shareholding spread of twenty-five percent (25%) of the issued and paid-up share capital.

2.2 Duration

The Proposed Share Buy-Back, once approved by the shareholders of EF, shall be effective from the date of the passing of the ordinary resolution pertaining to the Proposed Share Buy-Back at the forthcoming AGM and shall remain in force until: -

- i) the conclusion of the next AGM following the general meeting at which the ordinary resolution pertaining to the Proposed Share Buy-Back was passed, at which time it shall lapse unless by ordinary resolution passed at that meeting, the authority is renewed, either unconditionally or subject to conditions; or
- ii) the expiration of the period within which the next AGM after that date is required by law to be held; or
- iii) revoked or varied by ordinary resolution passed by the shareholders of our Company in a general meeting, whichever occurs first.

2.3 Source of funds

The maximum funds to be allocated by the Company for the purchase of the existing EF Shares in the open market shall be financed by internally generated funds and/or external borrowings. Pursuant to paragraph 12.10(1) of the Listing Requirements, the Proposed Share Buy-Back must be made wholly from the retained profits of the Company. The Company will ensure that the maximum funds to be utilised for the Proposed Share Buy-Back shall not exceed the total retained profits of the Company. The Proposed Share Buy-Back, if funded through internally-generated funds, is not expected to have a material impact on the cash flow position of the Company. In the event the Proposed Share Buy-Back is to be financed by bank borrowings, the Board will ensure that the Company has the capability to repay such borrowings and that such repayment will not have a material effect on the cash flow of the Company. The actual amount of funds to be utilised for the Proposed Share Buy-Back is to be purchased, availability of funds at the time of purchase(s) and other relevant cost factors.

Based on the latest audited financial statements of the Company for the FYE 31 December 2018, the retained profits of the Company are as follows:

2.4 Treatment of the Purchased Shares

Pursuant to Section 127(4) of the Act, where the Company has purchased the Shares, the Board may, at their discretion, resolve: -

- i) to cancel the shares so purchased;
- ii) to retain the shares so purchased in treasury, which is referred to as "treasury shares" in the Act; or
- iii) to retain part of the shares so purchased as treasury shares and cancel the remainder of the shares

Accordingly, based on Section 127(7) of the Act, where such Shares are held as treasury shares, the Board may, at their discretion: -

- i) distribute the shares as dividends to shareholders, such dividend to be known as "share dividends";
- ii) resell the shares or any of the shares in accordance with the relevant rules of Bursa Securities;
- iii) transfer the shares, or any of the shares for the purposes of or under an employees' share scheme;
- iv) transfer the shares, or any of the shares as purchase consideration;
- v) cancel the shares or any of the shares; or
- vi) sell, transfer or otherwise use the shares for such other purposes as the Minister may by order prescribe.

Upon each purchase of the Shares pursuant to the Proposed Share Buy-Back, an immediate announcement will be made to Bursa Securities in respect of the intention of the Board to either retain the Shares purchased as treasury shares or cancel them or a combination of both. An immediate announcement will also be made to Bursa Securities of any resale, transfer or cancellation of Shares so purchased.

2.5 Potential advantages and disadvantages

The potential advantages and disadvantages of the Proposed Share Buy-Back, if implemented, to the Company and the shareholders are as follows:

Potential advantages

- the Proposed Share Buy-Back will enable the Company to take preventive measures against market speculation and reduce volatility of EF Shares by stabilising the demand and supply of EF Shares that will maintain investors' confidence;
- the Proposed Share Buy-Back will provide the Company with opportunities for potential gains if the purchased Shares which are retained as treasury shares are resold at a higher price;
- (iii) the Proposed Share Buy-Back will allow the Company the flexibility in attaining the desired capital structure, in terms of debt and equity composition and size of equity; and
- (iv) in the event the treasury shares are distributed as share dividends, it will serve to reward the shareholders.

Potential disadvantages

- the Proposed Share Buy-Back will reduce the financial resources of the Group and may result in the forgoing of better investment opportunities that may emerge in the future; and
- (ii) as the Proposed Share Buy-Back may only be made out of the retained profits and/or share premium accounts of the Company, it may result in the reduction of financial resources available for distribution as dividends and/or bonus shares to the shareholders in the immediate future.

The Board will be mindful of the interests of the Company and the shareholders when undertaking the Proposed Share Buy-Back and in the subsequent resale of treasury shares on Bursa Securities, if any.

2.6 Public shareholding spread

The Proposed Share Buy-Back will be carried out in accordance with the prevailing laws at the time of the purchase including compliance with the 25% public shareholding spread requirement pursuant to Paragraph 8.02(1) of the Listing Requirement.

According to the Record of Depositors of the Company as at the LPD, the total percentage of the issued and paid-up share capital of EF which is held by the public (in accordance with the public shareholding spread requirements of Bursa Securities), was 59.33%, representing public shareholding of 246,299,746 EF Shares.

The Board will be mindful in ensuring that the minimum public shareholdings spread of 25% is met and maintained before making any purchases of the Shares.

2.7 Purchase price and resale or transfer price

i) Purchase price

Pursuant to Paragraph 12.17 of the Listing Requirement, the Company may only purchase its own Shares listed on Bursa Securities at a price which is not more than 15% above the weighted average market price of the Shares for the five (5) market days immediately before the date of the purchase.

ii) Resale or transfer price

Pursuant to Paragraph 12.18 of the Listing Requirement, the Company may only resell or transfer the Shares purchased which are held as treasury shares on Bursa Securities at: -

- a) a price which is not less than the weighted average market price for the Shares for the five (5) market days immediately before the resale or transfer; or
- b) a discounted price of not more than five percent (5%) to the weighted average market price for the Shares for the five (5) market days immediately before the resale or transfer provided that: -
 - the resale or transfer takes place not earlier than 30 days from the date of purchase; and
 - the resale or transfer price is not less than the cost of purchase of the Shares being resold or transferred.

The Company is required to make an immediate announcement to Bursa Securities of any purchase, resale, transfer or cancellation of the Shares pertaining to the Proposed Share Buy-Back.

2.8 Purchase of EF Shares and resale of Purchased Shares in the previous twelve (12) months

Given that this is the first time the Company is seeking authority from the shareholders for the Proposed Share Buy-Back, the Company does not currently hold any treasury shares and has not purchased, resold, transferred or cancelled any Shares during the last twelve (12) months preceding the LPD.

3. RATIONALE

The rationale for the Proposed Share Buy-Back is as follows: -

- allows the Company to take preventive measures against speculation to preserve the fundamental value of the Company which may in turn have a favourable impact on the share price of the Company. It is to be carried out when the share price is transacted at levels which do not reflect the potential earnings capabilities and/or underlying asset value of the Group;
- should any treasury shares be distributed as share dividends and/or issued under an employees' share scheme, this would also serve to reward the shareholders of the Company and/or the eligible persons;
- iii) enable the Company to utilise its surplus financial resources, which is not immediately required for other uses, to purchase the Shares from the open market at market prices which the Board views as favourable; and
- iii) if the Shares purchased are subsequently cancelled, long-term investors are expected to enjoy a corresponding increase in the value of their investments in the Company with the proportionate strengthening of the EPS and the NA per Share of the Group may improve (all things being equal).

4. EFFECTS OF THE PROPOSED SHARE BUY-BACK

4.1 Issued share capital

The pro forma effects of the Proposed Share Buy-Back on the number of issued Shares of the Company are as follows: -

The effect of the Proposed Share Buy-Back on the issued share capital of the Company will depend on the intention of the Board with regards to the treatment of the Shares purchased. If the Shares purchased are cancelled, the issued share capital will be reduced by the number of Shares so cancelled. Conversely, if the Shares purchased are retained as treasury shares, resold or distributed to shareholders, the Proposed Share Buy-Back will not have any effect on the issued share capital of the Company. Nevertheless, certain rights (such as voting rights) attached to the Shares purchased will be suspended when the Shares purchased are held as treasury shares.

4.2 NA and gearing

The effect of the Proposed Share Buy-Back on the consolidated NA of the Group will depend on, inter-alia, the number of purchased Shares, the purchase price of such purchased Shares, the effective funding cost to the Group to finance the purchased Shares or any loss in interest income to our Company and the proposed treatment of the purchased Shares.

If all the purchased Shares are cancelled, the Proposed Share Buy-Back will cause the NA per share of our Group to reduce in the event the purchase price of the purchased Shares exceeds the NA per Share of our Group at the time of purchase, and vice versa.

The NA of the Group would decrease if the purchased Shares are retained as treasury shares due to the requirement for treasury shares to be carried at cost and to be offset against equity, resulting in a decrease in the NA of the Group by the cost of the treasury shares.

In the event the treasury shares are resold through Bursa Securities for a profit, the NA per share of the Group will increase accordingly. If the treasury shares are distributed as share dividends, the NA per share of the Group will decrease by the cost of the treasury shares.

The effect of the Proposed Share Buy-Back on the gearing of the Company will depend on the proportion of borrowings utilised to fund any purchase of shares. Any borrowing utilised to purchase EF Shares may increase the gearing of the Company.

4.3 Working capital

The Proposed Share Buy-Back will reduce the working capital and cash flow of the Group, the quantum of which depends on, amongst others, the number of Shares purchased, the purchase price of the Shares and funding cost, if any.

For Shares purchased which are kept as treasury shares, upon its resale, the working capital and cash flow of the Group will increase assuming that a gain has been realised. The quantum of the increase in the working capital will depend on the actual selling price of the treasury shares and the number of treasury shares resold.

4.4 Earnings and EPS

The effects of the Proposed Share Buy-Back on the earnings and EPS of the Group will depend on the number of Shares purchased, the prices paid for such Shares, the effective funding cost to finance the purchase of such Shares, if any, or any loss in interest income to the Group. Nevertheless, all things being equal, assuming that the treasury shares are retained, the Proposed Share Buy-Back is expected to increase the EPS of the Group as the treasury shares held will not be taken into account in calculating the total number of issued Shares.

If the Shares purchased are cancelled, the number of Shares applied in the computation of EPS will reduce and accordingly, all things being equal, the Proposed Share Buy-Back will increase the EPS of the Group.

If the Shares purchased are resold, the extent of the impact to the EPS of the Group will depend on the actual selling price, the number of treasury shares resold and the effective gain on resale and any funding cost arising from the Proposed Share Buy-Back.

4.5 Dividend

The Proposed Share Buy-Back is not expected to have any impact on the policy of the Board in recommending dividends, if any, to the shareholders. Nonetheless, if the Shares purchased are retained as treasury shares, the treasury shares may be distributed as dividends to the shareholders, if the Company so decides.

If the Shares purchased are cancelled, the Proposed Share Buy-Back will have the effect of increasing the dividend rate of the Company as a result of the reduction in the number of issued Shares.

4.6 Shareholdings of the substantial shareholder and Directors

For illustration purposes, based on the Company's Record of Depositors as at the LPD, and assuming the Company acquires the maximum number of the Shares authorised under the Proposed Share Buy-back, the effect of the Proposed Share Buy-back on the shareholdings of the Directors and substantial shareholder of the Company are as follows: -

PROPOSED ADOPTION OF NEW CONSTITUTION OF THE COMPANY

1. INTRODUCTION

On 23 April 2019, the Company announced to Bursa Securities that it will seek shareholders' approval for the Proposed Adoption of New Constitution ("the Proposed Constitution").

The purpose of this Statement is to provide you with the information on the Proposed Constitution and to seek your approval on the same. This Proposed Constitution will be tabled at the 17th AGM as a special resolution.

You are advised to read and consider the contents of this Statement carefully prior to voting on the proposal at the 17th AGM. The notice of the 17th AGM and the proxy form are enclosed in the company's 2018 Annual Report.

2. DETAILS AND RATIONALE OF THE PROPOSED CONSTITUTION

The Proposed Constitution was recommended by the Board of Directors of EF ("the Board") in view of implementation of the new CA 2016 which came into force on 31 January 2017.

The primary objective is to streamline the M&A to be consistent with CA 2016, Main Market LR and other the prevailing statutory and regulatory requirements.

The details of the Proposed Constitution are set out in Appendix 2 of this Statement.

3. EFFECTS OF THE PROPOSED CONSTITUTION

The Proposed Constitution will not have any effect on the share capital of the Company and shall not have any material effect on the substantial shareholdings, net assets, gearing, earnings and earnings per share of the Group.

4. APPROVAL REQUIRED

The Proposed Constitution is subject to the approval of the shareholders at the 17th AGM by way of a Special Resolution.

5. INTEREST OF DIRECTORS, MAJOR SHAREHOLDERS AND/OR PERSONS CONNECTED WITH THEM

None of the Directors, Major Shareholders and/or persons connected with them has any interest, directly or indirectly, in the Proposed Constitution.

6. DIRECTORS' STATEMENT AND RECOMMENDATION

The Board, having considered all aspects of the Proposed Constitution, is of the opinion that the Proposed Constitution is in the best interest of the Company.

Accordingly, the Board recommends that the shareholders vote in favour on the resolution pertaining to the Proposed Constitution at the 17th AGM.

NAME

1. The name of the Company is EXCEL FORCE MSC BERHAD (Company No. 570777-X).

OFFICE

2. The registered office of the Company is situated in Malaysia.

DEFINITIONS AND INTERPRETATION

3. (1) In this Constitution unless the subject matter or context dictates **Definitions** otherwise, the following words and phrases shall have the meaning assigned to them herein:

"Act" means the Companies Act 2016 and any statutory modification, amendment or re-enactment thereof, and any and every other legislation for the time being in force made thereunder and any written law for the time being in force concerning companies and affecting the Company.

"Authorised Nominee" means an authorized nominee defined under the Central Depositories Act.

"Board" means the Board of Directors for the time being of the Company.

"Central Depositories Act" means the Securities Industry (Central Depositories) Act 1991, as it may be amended, modified or re-enacted from time to time.

"Clause" means these Clauses as originally framed or as altered from time to time by special resolution.

"Company" means EXCEL FORCE MSC BERHAD.

"Deposited Security" means a Security standing to the credit of a Securities Account and includes a Security in a Securities Account that is in suspense.

"Depositor" means a holder of Securities Account.

"Depository" means the Bursa Malaysia Depository Sdn. Bhd.

"Directors" means the Directors of the Company for the time being, include their duly appointed alternates.

"Dividend" means Dividend and or bonus.

"Electronic form" covers documents or information sent or supplied by electronic means or by any other means while in electronic form (such as by e-mail, text message, fax or sending a disk by post).

"Employee Share Scheme" means collectively a Share Issuance Scheme and a Share Grant Scheme.

"Exchange" means the Bursa Malaysia Securities Berhad.

"Exempt Authorised Nominee" means an authorised nominee defined under the Central Depositories Act, which is exempted from compliance with the provisions of subsection 25A(1) of the Central Depositories Act.

"Listed" means admitted to the Official List and "listing" shall be construed accordingly.

"Listing Requirements" means the Listing Requirements of the Exchange, as it may be modified or amended from time to time

"Market Day" means any day between Monday and Friday, which is not a market holiday of the Exchange or a public holiday.

"member(s)" means any person(s) whose name(s) is or are entered in the Company's register of members including Depositors whose names appear on the Record of Depositors except the Bursa Malaysia Depository Nominees Sdn. Bhd.

"month" means calendar month.

"Office" means the registered office of the Company.

"Omnibus Account" means Securities Account in which ordinary shares are held in the Company for multiple beneficial owners in one securities account.

"option" includes options under an Employee Share Scheme, convertible securities, warrants and any other types of options in respect of the issued or unissued securities of the Company.

"paid" means paid or credited as paid.

"Record of Depositors" means the record provided by the Central Depository to the Company under Chapter 24.0 of the Rules.

"Registrar" means the Registrar of the Company.

"Rules" means the Rules of the Depository and any appendices thereto as they may be amended or modified from time to time.

"Seal" means the Common Seal of the Company.

"Secretary" means any person or persons appointed to perform the duties of the secretary of the Company and shall include a joint, temporary, assistant or deputy secretary.

"Securities Account" means an account established by the Depository for a Depositor for the recording of deposit of Securities and for dealing in such Securities by the Depositor, as defined in the Central Depositories Act and or the Rules.

"Securities" means securities as defined in Section 2 of the Securities Commission Act 1993 or any modification, amendment or re-enactment thereof for the time being in force.

"share seal" means the share seal of the Company.

"shares" means shares in the Company.

"Statutes" means the Act, the Central Depositories Act, and every other Ordinance or Act for the time being in force concerning companies and affecting the Company.

The expressions "debenture" and "debenture-holder" shall include "debenture-stock" and "debenture-stockholder", and the expression "Secretary" shall include any person appointed by the Directors to perform any of the duties of the Secretary.

- (2) In this Constitution, unless there is something in the subject or context **Interpretation** inconsistent with such construction or unless it is otherwise expressly provided:
 - (a) reference to "writing" shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and other modes of representing or reproducing words in a visible form;
 - (b) words denoting the singular number only shall include the plural number, and vice versa, and words importing the masculine gender only shall include the feminine and neuter genders and the word "person" shall include a corporation;
 - (c) any reference to a statutory provision includes any modification, consolidation or re-enactment thereof for the time being in force, and all statutory instruments or orders made pursuant thereto; and
 - (d) save as aforesaid, words or expressions contained in this Constitution shall be interpreted in accordance with the provisions of the Interpretation Act 1967, as amended from time to time and any re-enactment thereof.

(3) The side notes are inserted for convenience only and shall not affect the construction of this Constitution.

OBJECTS

- 4. Section 21 of the Companies Act 2016 shall apply to the Company and the Company shall be capable of exercising all the functions of a body corporate and have the full capacity to carry on or undertake any business or activity the Directors considered advantageous to the Company and that are not prohibited under any law for the time being in force in Malaysia.
- 5. The objects for which the Company are established shall include but not limited to the following:
 - (a) To carry on business as concessionaires and merchants and to undertake, and carry on, and execute all kinds of commercial trading and other operations.
 - (b) To undertake any of the business of a holding company and to acquire and hold for investment shares, stock, debentures, debenture stock, bonds, obligations and securities issued or guaranteed by any Company or private undertaking or any syndicate or persons constituted or carrying on business in Malaysia or elsewhere.
 - (c) To carry on the business of importers and exporters of all kinds of merchandise including fertilizers, tyres, building materials of every description, textiles, photographic goods, electrical goods, watches, motor vehicles and yarns and prepare, manufacture and render marketable any such commodities either in their raw state or as prepared or manufactured and either by wholesale or retail.
- 6. The objects set forth in any sub-clause of the above clause shall not be restrictively construed but the widest interpretation shall be given thereto and they shall not, be in any way limited to or restricted by reference to or inference from any object or objects set forth in such sub-clause or from the terms of any other sub-clause or by the name of the Company. None of such sub-clauses or the object or objects therein specified or the powers thereby conferred shall be deemed subsidiary or ancillary to the objects or powers mentioned in any other subclause, but the Company shall have full power to exercise all or any of the powers and to achieve or to endeavour to achieve all or any of the objects conferred by and provided in any one or more of the said sub-clauses.

POWERS

- The powers of the Company in addition to those conferred under Section 21 of the Act shall include but not limited to the following:

- (a) To lend and advance money or give credit to any person or company; to guarantee and give guarantees or indemnities for the payment of money or the performance of contracts or obligations by any person or company; to secure or undertake in any way the repayment of moneys lent or advanced to or the liabilities incurred by any person or company; and otherwise to assist any person or company
- (b) To borrow or raise or secure the payment of money in such manner as the Company may think fit and to secure the same or the repayment or performance of any debt, liability, contract, guarantee or other engagement incurred or to be entered into by the Company in any way and in particular by the issue of debentures perpetual or otherwise, charged upon all or any of the Company's property (both present and future), and to purchase, redeem, or pay off any such securities

LIABILITY OF MEMBERS

8. The liability of the members of the Company is limited.

SHARES CAPITAL

- 9. The share capital of the Company is its issued share capital which shall **Share Capital** be in Ringgit Malaysia. The shares in the original or any increased capital may be divided into several classes and there may be attached thereto, respectively, any preferential, deferred, qualified or other special rights, privileges, conditions or restrictions as to dividend, capital, voting or otherwise.
- 10. Without prejudice to any special rights previously conferred on the **Authority of** holders of any existing shares or class of shares, and subject to Section **Directors to** 75 of the Act and to the conditions, restrictions and limitations expressed in this Constitution, the Directors shall have the power to issue and allot shares, grant options over shares, grant rights to subscribe for shares.
- 11. Except so far as otherwise provided by the conditions of issue, or by this **New Shares** Constitution, any capital raised by the creation of new shares, shall form Part form part of the capital of the Company, and such shares shall be subject to the provisions contained in this Constitution with reference to, the payment of calls and instalments, transfer and transmission, forfeiture, lien, cancellation, surrender, voting and otherwise.
- 12. The Company shall have power to issue preference capital ranking **Power to Issue** equally with or in priority to preference shares already issued and the **Preference** Directors may, subject to the provisions of the Act, redeem such shares on such terms and in such manner as they may think fit.

- 13. (1) Save as otherwise specifically provided for under this Constitution in Rights of respect of any particular class of preference share, preference Preference shareholders shall have the same right as ordinary shareholders as Shareholders regards to receiving notices, reports and audited financial statements and attending general meetings of the Company.
 - (2) Save as otherwise specifically provided for under this Constitution in respect of any particular class of preference share, preference shareholders shall also have the right to vote at any meeting convened for the purpose of reducing the share capital of the Company or sanctioning a disposal of the whole of the Company's property, business and undertaking or where the proposition to be submitted to the meeting directly affects their rights and privileges, or when the dividend or part of the dividend on the preference shares is in arrears for more than six (6) months or on a proposal to wind up the Company or during the winding up of the Company, but shall have no other rights whatsoever.
 - (3) The holder of a preference share must be entitled to a return of capital in preference to holders of ordinary shares when the Company is wound up.
- 14. The Company shall not give, whether directly or indirectly, and whether No Financial by means of a loan, guarantee, the provision of security or otherwise, Assistance any financial assistance for the purpose of or in connection with a purchase or subscription made or to be made by any person of or for any shares in the Company or in its holding company, nor shall the Company make a loan for any purpose whatsoever on the security of its shares or those of its holding company, but nothing in this Clause shall prohibit transactions mentioned in Section 127 of the Act or the circumstances set out in Section 127 of the Act.
- 15. Subject to the provisions of the Act and the rules, regulations, orders, Purchase of guidelines or requirements issued by the Exchange and/or any other relevant authority from time to time, the Company may by ordinary resolution purchase its own shares. Any shares in the Company, so purchased by the Company, shall be dealt with in accordance with the Act and the guidelines or requirements issued by the Exchange and or any other relevant authority from time to time.
- 16. Provided however that in the event of the necessary majority for such a resolution not having been obtained in the manner aforesaid consent in writing may be secured by members holding at least three- fourths of the issued shares of the class and such consent if obtained within two (2) months from the date of the separate meeting shall have the force and validity of a resolution duly carried. If any member fails to pay the whole or any part of any call or **Notice to Pay** instalment of a call on the day appointed for the payment thereof, the Directors may at any time thereafter during such time as any part of the call or instalment remains unpaid, serve a notice on him requiring payment of so much of the call or instalment as is unpaid, together with any interest which may have accrued.
- 37. The notice shall name a further day (not being less than fourteen (14) **Period of** days from the date of service of the notice) on or before which, and the place where, the payment required by the notice is to be made, and shall state that, in the event of non-payment at or before the time and place appointed, the shares in respect of which such call was made will be liable to be forfeited.
- 38. If the requirements of any such notice as aforesaid are not complied **Forfeiture for** with, any share in respect of which such notice has been given may at any time, thereafter, before payment of all calls and interest due in respect thereof has been made, be forfeited by a resolution of the Directors to that effect. Such forfeiture shall include all dividends which shall have been declared on the forfeited shares and not actually paid before the forfeiture. The Directors may accept the surrender of any share liable to be forfeited hereunder.
- 39. Notwithstanding any such forfeiture as aforesaid, the Directors may at **Annulment of** any time before the forfeited share has been otherwise disposed of, **Forfeiture** annul the forfeiture upon the terms of payment of all calls and interest due upon and expenses incurred in respect of the share and upon such further terms (if any) as they shall see fit.
- 40. Subject to the Central Depositories Act and the Rules, a share so *SI* forfeited or surrendered shall become the property of the Company *Fa* and may be re-sold, re-allotted or otherwise disposed of either to the *Ba* person who was before such forfeiture or surrender the holder thereof *Ca* or entitled thereto, or to any other person upon such terms and in such manner as the Directors shall think fit, and at any time before a sale, re-allotment or disposition the forfeiture or surrender may be cancelled on such terms as the Directors think fit. The Directors may, if necessary, authorise some person to transfer a forfeited or surrendered share to any such other person as aforesaid.

- 41. A person whose shares have been forfeited or surrendered shall cease to be a member in respect of the forfeited or surrendered shares, but shall, notwithstanding, remain liable to pay to the Company all moneys which, at the date of forfeiture or surrender were payable by him to the Company in respect of the shares together with interest from the date of forfeiture or surrender on the money for the time being unpaid, if the Directors think fit to enforce payment of such interest) but his liability shall cease if and when the Company receives payment in full of all such moneys in respect of the shares. 42. The Company may receive the consideration, if any, given for the share on any sale or disposition thereof and the Directors may authorise some person to execute a transfer of the share in favour of the person to whom the share is sold or otherwise disposed of and he shall thereupon be registered as the holder of the share, and shall not be bound to see to the application of the purchase money, if any, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale or other disposal of the share. Subject to any lien for sums not presently payable, if any, any residue of the proceeds of the sale of shares which are forfeited and sold, after the satisfaction of the unpaid calls or instalments payable at fixed times and accrued interest and expenses, shall be paid to the person whose shares have been forfeited or his executors, administrators or assignees or as he directs.
- 43. The provisions of this Constitution as to forfeiture shall apply in the case of non-payment of any sum which, by the terms of issue of a share, becomes payable at a fixed time, whether on account of the nominal value of the share or by way of a premium, as if the same had been payable by virtue of a call duly made and notified.
- 44. When any share has been forfeited in accordance with this Notice of Constitution, notice of the forfeiture shall forthwith be given to the Forfeiture holder of the share or to the person entitled to the share by reason of Provision the death or bankruptcy as the case may be, and an entry of such notice having been given, and of the forfeiture with the date thereof shall forthwith be made in the Record of Depositors opposite to the share.
- 45. The forfeiture of a share shall involve the extinction at the time of Results of forfeiture of all interest in and claims and demands against the Company in respect of the share and all other rights and liabilities incidental to the share as between the shareholder whose share is forfeited and the Company, except only such of those rights and liabilities as are by this Constitution expressly saved or as are by the Act given or imposed in the case of past members.

- 50. (1) Every instrument of transfer (for any share not being a deposited *Instrument of* security) must be left for registration at the office of the Company's *Transfer* Registrar accompanied by the certificate of the shares comprised therein and such evidence as the Directors may reasonably require to prove the right of the transfer to make the transfer and the due execution by him of the transfer, and subject to the power vested in the Directors by this Constitution or the provisions of any other written law and if required, to reasonable evidence of nationality, the Company shall register the transferee as shareholder.
 - (2) A fee not exceeding RM3.00 (excluding the stamp duty) or any amount as shall be determined from time to time by the Exchange may be charged for each transfer and shall if required by the Directors be paid before the registration thereof.

- 51. No share shall in any circumstances be transferred to any infant, *Person Under* bankrupt or person of unsound mind. *Disability*
- 52. (1) Subject to Section 106 and any other relevant provisions of the Act, the **Refusal to** Directors may refuse or delay to register the transfer of a share, not **Transfer** being a deposited security, (not being a fully paid share) to a person of whom they shall not approve.
 - (2) If the Directors passed a resolution to refuse or delay the registration of **Notice of** a transfer, they shall, within seven (7) days of the resolution being passed, give to the lodging broker, transferor and the transferee written notice of the resolution setting out the precise reasons thereof.
- 53. Neither the Company nor its Directors nor any of its officers shall incur Non-Liability of any liability for registering or acting upon a transfer of shares the Company, apparently made by sufficient parties, although the same may, by its Directors reason of any fraud or other cause not known to the Company or its and Officers in Directors or other officers be legally inoperative or insufficient to pass Respect of the property in the shares proposed or professed to be transferred, and Transfer although the transfer may, as between the transferor and transferee, be liable to be set aside, and notwithstanding that the Company may have notice that such instrument of transfer was signed or executed and delivered by the transferor in blank as to the name of the transferee or the particulars of the shares transferred or otherwise in defective manner. And in every such case, the person registered as transferee, his executors, administrators and assigns alone shall be entitled to be recognised as the holder of such shares and the previous holder shall, so far as the Company is concerned, be deemed to have transferred his whole title thereto.

- (a) the securities of the Company are listed on another stock exchange; and
- (b) the Company is exempted from compliance with Section 14 of the Central Depository Act or Section 29 of the Securities Industry (Central Depositories) (Amendment) Act 1998, as the case may be, under the Rules of the Depository in respect of such securities, the Company shall, upon request of a securities holder, permit a transmission of securities held by such securities holder from the register of holders maintained by the Registrar of the Company in the jurisdiction of the other stock exchange, to the register of holder maintained by the Registrar of the Company in Malaysia, and vice versa, provided that there shall be no change in the ownership of such securities.
- 55. Any person becoming entitled to a share which is a Deposited Security **De** in consequence of the death or bankruptcy of a member may apply to **of** the Depository to transfer the shares into his Securities Account supported by the relevant documents and in accordance with the Central Depositories Act and or the Rules. The said person shall deliver

The holders of stock may transfer the same or any part thereof in the **Holder of** same manner and subject to the same clauses as and subject to which the shares from which the stock arose might previously to conversion have been transferred or as near thereto as circumstances admit; **Interest** provided, however, that the Directors may from time to time, if they think fit, fix the minimum amount of stock transferable and restrict or forbid the transfer of fractions of that minimum, but the minimum shall not exceed the nominal amount of the shares from which the stock arose.
- 58. The stock shall confer on the holders thereof respectively the same **Pai** rights, privileges and advantages as regards dividends, participation in **Div** assets on a winding up, voting at meetings of the Company and other matters as would have been conferred by the shares from which the stock arose, but so that none of such rights, privileges or advantages, (except participation in dividends and profits of the Company and in assets on a winding up) shall be conferred by an amount of the stock which would not, if existing in shares, have conferred such right, privilege or advantage.
- 59. All such provisions of this Constitution as are applicable to paid-up **Appli** shares shall apply to stock, and in all such provisions, the word "share" **this C** shall include "stock" and the word "shareholder" and "member" shall include "stockholder".

- 60. The Company may, from time to time, whether all the shares for the **Increase of** time being issued shall have been fully paid up or not, by ordinary resolution increase its share capital by the creation and issue of new shares, such new capital to be of such amount to be divided into shares of such respective amounts and to carry such rights or to be subject to such conditions or restrictions in regard to dividend, return of capital or otherwise as the Company may direct in the resolution authorising such increase.
- 61. Subject to any direction to the contrary that may be given by the **Issue of New** Company in general meeting, all new shares or other convertible Shares to Securities shall, before they are issued, be offered to such persons as at **Existing** the date of the offer are entitled to receive notices from the Company Members of general meetings in proportion, as nearly as the circumstances admit, to the amount of the existing shares or Securities to which they are entitled. The offer shall be made by notice specifying the number of shares or Securities offered, and limiting a time within which the offer, if not accepted, will be deemed to be declined, and, after the expiration of that time, or on the receipt of an intimation from the person to whom the offer is made that he declines to accept the shares or Securities offered, the Directors may dispose of those shares or Securities in such manner as they think most beneficial to the Company. The Directors may, likewise, also dispose of any new shares or Securities which (by reason of the ratio which the new shares or Securities bear to shares or Securities held by persons entitled to an offer of new shares or Securities) cannot, in the opinion of the Directors, be conveniently offered under this Clause.

ALTERATION OF CAPITAL

- 62. The Company may alter its share capital by passing an ordinary *Alteration of* resolution to: *Share Capital*
 - (a) consolidate and divide all or any of its share capital, the proportion between the amount paid and the amount, if any, unpaid on each subdivided share, shall be the same as it was in the case of the share from which the subdivided share is derived;

(b) convert all or any of its paid-up shares into stock and may reconvert that stock into paid-up shares;

(c) subdivide its shares or any of the shares, whatever is in the subdivision, the proportions between the amount paid and the amount, if any, unpaid on each subdivided share shall be the same as it was in the case of the share from which the subdivided share is derived; or

(d) cancel any shares, which at the date of the passing of the resolution, which have been forfeited, and diminish the amount of its share capital by the amount of the shares so cancelled.

- 72. The accidental omission to give notice of any meeting to or the nonreceipt of the notice of a meeting by, any person entitled to receive notice shall not invalidate any resolution passed or proceedings held at any such meeting.
- 73. A meeting shall, notwithstanding that it is called by notice shorter than is required by Clause 68, be deemed to be duly called if it is so agreed, in the case of a meeting called as the annual general meeting, by all the members entitled to attend and vote thereat or in the case of an extraordinary general meeting, by a majority in number of the members having a right to attend and vote thereat, being a majority which together holds not less than ninety-five per cent (95%) of the shares giving a right to attend and vote.

PROCEEDINGS AT GENERAL MEETINGS

- 76. All business that is transacted at any extraordinary general meeting and Special also all business that is transacted at an annual general meeting shall be **Business** deemed special, with the exception of the receipts and consideration of the audited financial statements and audited group financial statements (if any) of the Company and the reports of the Directors and auditors and other documents required to be annexed to the financial statements, the election of Directors in the place of those retiring, the fixing of the fees and benefits of Directors, and the appointment of, and the fixing of the remuneration of the auditors.
- 77. No business shall be transacted at any general meeting unless a Quorum quorum is present at the time when the meeting proceeds, to business. For all purposes, two (2) members, present in person or by proxy, or, in the case of corporations which are members, present by their representatives appointed pursuant to the provision of this Constitution and entitled to vote, shall be a guorum.
- 78. If within half an hour after the time appointed for the meeting a quorum is not present, the meeting, if convened by or upon the requisition of members, shall be dissolved. If otherwise convened, it shall stand adjourned to the same day in the next week (or if that day be a public holiday, then to the next business day following such public holiday), at the same time and place or to such other day and at such other time and place as the Directors may determine, but if a quorum is not present within fifteen (15) minutes from the time appointed for holding the adjourned meeting, the members present shall be a quorum and may transact the business for which the meeting was called, but no notice of any such adjournment as aforesaid shall be required to be given to the members.
- 79. The Chairman of the Board, shall preside as Chairman at every general meeting, but if no such Chairman is present within fifteen (15) minutes after the time appointed for holding the meeting, or shall decline to take or shall retire from the chair, the Directors present shall choose one of their number to act as Chairman of such meeting, and if there be no Director chosen who shall be willing to act, the members present in person or by proxy and entitled to vote shall choose one (1) of their own number to act as Chairman at such meeting.
- 80. The Chairman may, with the consent of any meeting at which a quorum is present and if so directed by the meeting, shall adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place. When a meeting is adjourned for thirty (30) days or more, notice of the adjourned meeting shall be given as in the case of an original meeting. Save as aforesaid, it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.
- 81. A resolution in writing signed by all the members of the Company or their agents authorised in writing shall (except where a meeting is prescribed by the Act) be as valid and effectual as if it had been passed at a meeting of the members duly convened and held, and such

- 82. Subject to any express requirement of the Listing Requirements, at any general meeting, a resolution put to the vote of the meeting shall be determined by a show of hands of the members present in person or by proxy, unless a poll is demanded (before or upon the declaration of the result of a show of hands):
 - (a) by the Chairman of the meeting (being a person entitled to vote);
 - (b) by at least three (3) members present in person or by proxy;
 - (c) by any member or members present in person or by proxy representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
 - (d) by a member or members present in person or by proxy and holding shares in the Company conferring a right to vote at the meeting, being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right;

Provided that no poll shall be demanded on the election of Chairman of a meeting or on any question of adjournment.

Unless a poll is duly demanded in accordance with the foregoing provisions, a declaration by the Chairman that a resolution has been carried or carried unanimously or by a particular majority or lost, and an entry to that effect in the minutes of the proceedings of the Company, shall be conclusive evidence of the fact, without proof of the number, proportion or validity of the votes, recorded in favour of or against such resolution.

- 83. - 84. If any votes shall have been counted, which ought not to have been **Counting of** counted, or might have been rejected, the error shall not vitiate the **Votes** result of the voting unless it be pointed out at the same meeting or at any adjournment thereof and unless in the opinion of the Chairman at the meeting or any adjournment thereof as the case may be, it shall be of sufficient importance to vitiate the result of the voting.
- 85. If a poll is duly demanded it shall be taken in such manner as the **Taking of Poll** Chairman may direct (including the use of a ballot or voting papers or tickets or electronically using various forms of electronic voting devices)

and the result of the poll shall be the resolution of the meeting at which the poll was demanded. Unless the result of the poll is computed or determined electronically, the Chairman shall appoint scrutineers to verify the votes which shall be counted by the poll administrators for the purposes of a poll, and may adjourn the meeting to some place and time fixed by him for the purpose of determining the results of the poll.

Any member being of unsound mind or whose person or estate is liable to be dealt with in any way under the law relating to mental disorder, may vote, whether on a show of hands or on a poll, by his committee, receiver, curator bonis, or other legal guardian or such other person who has been properly appointed to manage his estate. Any one (1) of such committee or other person may vote either by proxy or by attorney, provided such evidence, as the Directors may require of the authority of the person claiming to vote, shall have been deposited at the Office not less than forty-eight (48) hours before the time appointed for holding the meeting.
- 93. The legal personal representative of a deceased member or the person entitled under Clause 55 to any share in consequence of the death or bankruptcy of any member may vote at any general meeting in members respect thereof in the same manner as if he was the registered holder of such shares, provided that forty-eight (48) hours at least before the time of holding the meeting, or adjourned meeting as the case may be at which he proposes to vote he shall satisfy the Directors of his right to any share in consequence of the death or bankruptcy of any member unless the Directors shall have previously admitted his right to vote in respect thereof.
- 94. No member shall be entitled to be present or to vote at any general **Members in** meeting or to exercise any privilege as a member nor be counted as **Default** one of the quorum unless all calls or other sums immediately payable by him in respect of shares in the Company have been paid.
- 95. No objection shall be raised in respect of the qualification of any voter **Time for** except at the meeting or adjourned meeting at which the vote objected **Dbjection of** to is given or tendered, and every vote not disallowed at such meeting **Any Voter's** shall be valid for all purposes. Any such objection made in due time shall be referred to the Chairman of the meeting, whose decision shall be final and conclusive.
- 96. The instrument appointing a proxy shall be in writing under the hand of **Instrument of** the appointor or of his attorney duly authorised in writing or, if the appointor is a corporation, either under the corporation's seal or under the hand of an officer or attorney duly authorised. The Directors may, but shall not be bound to require evidence of the authority of any such attorney or officer. An instrument appointing a proxy to vote at a meeting shall be deemed to include the power to demand a poll on behalf of the appointor.
- 97. Where a member of the company is an exempt authorised nominee **Appointment of** which holds ordinary shares in the company for multiple beneficial **Multiple** owners in one securities account ("omnibus account"), there is no limit to the number of proxies which the exempt authorized nominee may appoint in respect of each omnibus account it holds.

- 100. The instrument appointing a proxy and the power of attorney, or other Deposit of authority (if any) under which it is signed, or a certified copy of such Proxy power or authority by a notary public, shall be deposited at the Office or at such other place within Malaysia, as is specified for that purpose in the notice convening the meeting, not less than forty-eight (48) hours before the time appointed for holding the meeting or adjourned meeting at which the person named in the instrument, proposes to vote or, in the case of a poll, not less than twenty-four (24) hours before the time appointed for the taking of the poll, and in default, the instrument of proxy shall not be treated as valid, PROVIDED ALWAYS that the Company may by written notice waive the prior lodgement of the above instrument appointing a proxy and the power of attorney or other authority.
- 101. - 103. Until otherwise determined by the Company in general meeting the **Number of** number of Directors shall not be less than two (2) and not more than **Director** eleven (11). All the Directors of the Company shall be natural persons.
- 104. The shareholding qualification for Directors may be fixed by the **Share** Company in general meeting, and until so fixed, no shareholding **Qualification of** qualification for Directors shall be required. All Directors shall be entitled to receive notice of and to attend and speak at all general meetings of the Company.
- 105. (1) An election of Directors shall take place each year at the annual general meeting of the Company, where one-third of the Directors for the time being, or, if their number is not three (3) or a multiple of three (3), then **Directors** the number nearest to one-third shall retire from office and be eligible for re-election, PROVIDED ALWAYS that Directors shall retire from office once at least in each three (3) years but shall be eligible for re-election. A retiring Director shall retain office until the close of the meeting at which he retires.

- (2) The Directors to retire in every year shall be those who have been Senior Director longest in office since their last election, but as between persons who to Retire became Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by lot.
- 106. - 108. The Company may by ordinary resolution appoint another person in place of a Director so removed from office, and any person so appointed shall be subject to retirement by rotation at the same time as if he had become a Director on the day on which the Director in whose place he is appointed was last elected a Director. In default of such appointment, the vacancy so arising may be filled by the Directors as a casual vacancy.
- 114. - 115. The fees and any benefits payable to the Directors from time to time, **Remuneration** be determined by an ordinary resolution of the Company and shall (unless such resolution otherwise provides) be divisible among the Directors as they may agree, except that any Director, who shall hold

office for part only of the period in respect of which such fees are payable, shall be entitled only to rank in such division for a proportion of the fees related to the period during which he has held office, Provided Always that:

The Directors may establish any committees, local boards or agencies, comprising of one or more such member, as members of its body, for managing any of the affairs of the Company, either in Malaysia or elsewhere, and may lay down, vary or annul such rules and regulations as they may think fit for the conduct of the business thereof, and may appoint any other person or persons to be the member or members of any such committee or local board or agency and may fix their remuneration, and may delegate to any such committee or local board or agency any of these powers, authorities and discretion vested in the Directors, with power to sub-delegate, and may authorise the member or members of any such committee or local board, or any of them, to fill any vacancies therein, and to act notwithstanding vacancies, and any such appointment or delegation may be made upon such terms and subject to such conditions as the Directors may think fit, and the Directors may remove any person so appointed, and may annul or vary any such delegation, but no persons dealing in good faith without notice of any such annulment or variation shall be affected thereby.
- 143. Notwithstanding any provisions to the contrary contained in this **Partic** Constitution, any member of a committee may participate at a **Comm** committee meeting by way of telephone and video conferencing or by **Meeti** means of other communication equipment, whereby all persons **Way of** participating in the meeting are able to hear each other, in which event **Teleph** such member shall be deemed to be physically present at the meeting **Video**

Director May Become Directors or Other Officers of Any Corporation Promoted by the Company

Directors May Establish Committees, Etc

Participation at Committee Meetings by Way of Telephone and Video whether for the purposes of these Articles or otherwise. A member participating in a meeting in the manner aforesaid may also be taken into account in ascertaining the presence of a quorum at the meeting. Any meeting held in such manner shall be deemed to be held at such place as shall be agreed upon by the members attending the meeting, PROVIDED that at least one (1) of the members present at the meeting was at such place for the duration of that meeting.

- 144. The meetings and proceedings of any such committee consisting of **Meeting of the** three (3) members shall be governed by the provisions herein **Committee** contained for regulating the meetings and proceedings of the Directors, so far as the same are applicable thereto and are not superseded by a regulation made by the Directors under the last preceding Article.
- 145. Subject to any rules and regulations made hereunder, a committee may **Proceedings of** meet and adjourn as it thinks proper, and questions arising at any **the Committee** meeting shall be determined by a majority of votes of the members present (if more than one), and in the case of an equality of votes, the Chairman shall have a casting vote.
- 146. A committee, local board or agency may elect a Chairman of its **Chairman of** meetings, if no such Chairman is elected, or if at any meeting, the **Chairman** is not present within five (5) minutes after the time appointed for holding of the meeting, the members present may choose one (1) of their number to be the Chairman at the meeting.

VALIDATION OF ACTS OF DIRECTORS

147. All acts done by any meeting of the Directors or a Committee of Va. Directors or by any person acting as a Director, local board or agency the shall, notwithstanding that it is afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they, or any of them were disqualified, or had vacated office or were not entitled to vote, be as valid as if every such person had been duly appointed and was qualified and had continued to be a Director or member of such committee, local board or agency as aforesaid and had been entitled to vote.

CIRCULAR RESOLUTIONS

148. A resolution in writing signed or approved by letter, telegram, telex, Circular telefax or electronic means by all the Directors, for the time being Resolution entitled to receive notice of a meeting of Directors, shall be as valid and effectual as if it had been passed at a meeting of the Directors duly called and constituted; provided that where a Director is not so present but has an alternate who is so present, then such resolution shall also be signed by such alternate. All such resolutions shall be described as "Directors' Resolution In Writing" and shall be forwarded or otherwise delivered to the Secretary without delay, and shall be recorded by him in the Company's Minute Book. Any such resolution in writing may consist of several documents, including facsimile or other similar means of communication, in similar form, and each document shall be signed or assented to by one or more Directors or their alternates. A copy of any such resolution shall be entered in the minutes book of Board proceedings.

MANAGING DIRECTOR

- 149. The Directors may from time to time appoint any one or more of their body to be Managing Director or Managing Directors. Subject to Clause 105 (1), any such appointment shall be subject to reappointment and on such terms as they think fit, and may vest in such Managing Director or Managing Directors, as may be appointed by them such of the powers hereby vested in the Directors generally as they may think fit. The Managing Director or Managing Directors shall be subject to the control of the Board.
- 150. The remuneration of the Managing Director or Managing Directors shall **Remuneration** subject to the terms of any agreement entered into in any particular **of Managing** case may be by way of salary or commission or participation in profits or otherwise or by any or all of these modes but such remuneration shall not include a commission on or percentage of turnover but it may be a term of their appointment that they shall receive pension, gratuity or other benefits upon their retirement.
- 151. The Managing Director or Managing Directors shall, while they continue Managing to hold such offices, be subject to retirement by rotation in accordance Director with Clause 105, and they shall, subject to provisions of any contract Reckoned as between them and the Company, be subject to the same provisions as Director for to resignation and removal as the other Directors of the Company and, Purposes of if they cease to hold the office of Director from any cause, they shall Rotation and ipso facto and immediately cease to be Managing Director or Managing Retirement Directors.

MINUTES AND REGISTERS

- 152. The Directors shall cause minutes to be duly entered in books provided *Minutes* for the purpose:
 - (a) of all appointments of officers;
 - (b) of the names of all the Directors present at each meeting of the Directors and of any committee of Directors and of the Company in general meeting;
 - (c) of all resolutions and proceedings of general meetings and of meetings of the Directors and committees of Directors; and
 - (d) of all orders made by the Directors and any committee of Directors.

Such minutes shall be signed by the Chairman of the meeting at which the proceedings were held or by the Chairman of the next succeeding meeting and if so signed, shall be conclusive evidence without any further proof of the facts thereon stated.

- 153. Where a resolution is passed at an adjourned meeting of the Board, the Resolution resolution shall, for all purposes, be treated as having been passed on Passed at the date on which it was in fact passed and shall not to be deemed to Adjourned have been passed on any earlier date. Meeting 154. The Company shall in accordance with the provisions of Section 57 of Register of the Act, keep at the Office, or such other place, provided notice has Directors. been given to the Registrar of Company, a register containing such Manaaers and particulars with respect to the Directors, managers and secretaries of Secretaries the Company as are required by the Act, and shall from time to time notify the Registrar of Companies of any change in such register and of the date of such change in manner prescribed by that section. 155. The books containing the minutes of proceedings of any general Minute Books meeting shall be kept by the Company at the Office, or such other in Registered place, provided notice has been given to the Registrar of Company, and Office shall be open to the inspection of any member without charge. 156. The Company shall also keep at the Office, or such other place, provided notice has been given to the Registrar of Company, a register which shall be open to the inspection of any member without charge and to any other person on payment of such prescribed fee as may be determined by the Company, all such matters required to be so registered under the Act, and in particular: (a) a register of substantial shareholders and of information received **Registers** of in pursuance of the requirements under Section 137 and 138 of the **Substantial Shareholders** Act; (b) a register of the particulars of each of the Directors' shareholdings Register of and interests as required under Section 59 of the Act; and Directors' Shareholdings (c) a register of mortgages and charges as required under Section 357 Register of of the Act. - 157. The Directors may from time to time appoint any person to be an **Associate** associate Director and may, from time to time, cancel any such **Director** appointment. The Directors may fix, determine and vary the powers, duties and remuneration of any person so appointed, but a person so appointed shall not be required to hold any shares to qualify him for appointment nor have any right to attend or vote at any meeting of Directors except by the invitation and with the consent of the Directors.

THE SECRETARY

158. The Secretary or Secretaries shall, in accordance with the Act, be **Appointment of** appointed by the Directors for such term, at such remuneration, and upon such conditions as the Directors think fit, and any Secretary or Secretaries so appointed may be removed by them but without prejudice to any claim he or they may have for damages for breach of any contract of service with the Company. The Directors may, from time to time, by resolution appoint a temporary substitute for the Secretary, who shall be deemed to be the Secretary during the term of his appointment.

159 The Secretary may resign from his office in accordance with the Act and **Resignation of** any resignation shall be effective within thirty (30) days of the notice of **Secretary** resignation. The Board shall appoint another person as Secretary within thirty (30) days of receipt of the outgoing Secretary's notice of resignation in compliance with the Act.

SEAL

- 160. The Directors shall provide for the safe custody of the Seal, which shall The Custody only be used pursuant to a resolution of the Directors, or a committee and the of the Directors authorised to use the Seal. The Directors may, from Affixing of the time to time (subject to the provisions of Clause 24 in relation to share Seal and debenture stock certificates and debentures), make such regulations as they think fit determining the persons and the number of such persons in whose presence the Seal shall be affixed and, until otherwise so determined, every instrument to which the Seal shall be affixed shall (subject to Clause 24) be signed by a Director and either by the Secretary or by a second Director or by some other person appointed by the Directors for the purpose, Provided Always that no person dealing with the Company shall be concerned to see or enquire as to whether any regulations so made have been complied with.
- 161. The Company may also have a share seal pursuant to Section 63 of the **The Share Seal** Act. The share seal is a duplicate or facsimile of the Seal with the addition on its face of the words "Share Seal" which is specifically affixed onto certificates that may be issued by the Company for any share, stock, loan stock, debentures as defined in the Act, or other marketable security created or issued by the Company.

SEAL FOR USE ABROAD

162. The Company or the Directors, on behalf of the Company, may exercise **Seal for Use** the powers, conferred by the provisions of the Act, with regard to **Abroad** having an official Seal for use abroad, and the powers conferred by the provisions of the Act with regard to the keeping of a branch Register.

RESERVES

163. The Directors may, before recommending any dividend, whether **Creation of** preferential or otherwise, set aside out of the profits of the Company such sums as they think proper as a reserve fund to meet depreciation or contingencies, or for equalising dividends or for the payment of special dividends, or for the general liquidation of any debt or liability of the Company or for repairing, improving or maintaining any of the property of the Company, or for such other purposes (being purposes for which the profits of the Company may lawfully be applied) as the Directors shall in their absolute discretion think conducive to the interest of the Company, and may invest the several sums so set aside upon such investments as they think fit (including purchasing shares in the Company to the extent and in the manner allowed by the Act and subject to the provisions of this Constitution) and, from time to time, vary or realise such investments and dispose of all or any part thereof for the benefit of the Company, and may divide any reserve fund into such special funds as they think fit, with all power to employ the assets constituting the reserve fund in the business of the Company, and without being bound to keep the same separate from the other assets. The Directors may also, without placing the same to reserve, carry forward any profits which they may think prudent not to divide.

DIVIDEND

- 164. The profits of the Company available for dividend and determined to be **Payment of** distributed shall be applied in the payment of dividends to the **Dividends** members in accordance with their respective rights and priorities. The Company in general meeting may declare dividends accordingly.
- 165. Without prejudice to the powers of the Company to pay interest on **Dividends** share capital as hereinbefore provided, no dividend shall be paid otherwise than out of profits nor shall any dividend or other monies payable on or in respect of any share bear interest against the Company and no dividend shall be paid in excess of the amount recommended by the Directors.
- 166. Subject to the rights of persons (if any) entitled to shares with special Dividends in rights as to dividend, all dividends shall be declared and paid according Proportion to to the amounts paid up on the shares in respect whereof the dividend is **Amounts Paid** paid, but no amount paid up on a share in advance of call shall be Up treated for the purposes of this Clause as paid up on the share. All dividends shall be apportioned and paid pro-rata according to the amounts paid up on the shares during any portion or portions of the period in respect of which the dividend is paid, except that if any share is issued on terms providing that it shall rank for dividend as if paid up (in whole or in part) as from a particular date, such share shall rank for dividend accordingly.
- 167. The Directors may if they think fit from time to time pay to the Dividend members such dividends as appear to the Directors to be justified by the profits of the Company. If at any time the share capital of the Company is divided into different classes, the Directors may pay such dividends in respect of those shares in the capital of the Company which confer on the holders thereof deferred or non-preferential rights as well as in respect of those shares which confer on the holders thereof preferential rights with regard to dividend and, provided that the Directors act bona fide, they shall not incur any responsibility to the holder of shares conferring any preferential rights for any damage that they may suffer by reason of the payment of a dividend on any shares having deferred or non-preferential rights. The Directors may also pay half-yearly, or at other suitable intervals to be determined by them, any dividend which may be payable at a fixed rate, if they are of the opinion that the profits justify the payment.
- 168. The Directors may deduct from any dividend payable to any member all **Debts May be** sums of money (if any) immediately payable by him to the Company on **Deducted from** account of calls or otherwise in relation to the shares of the Company **Dividends** held by him.

- 169. The Directors may retain any dividend or other moneys payable on or in **Power to** respect of a share other than fully paid shares on which the Company **Retain** has a lien, and may apply the same in or towards satisfaction of the **Dividends** debts, liabilities or engagements in respect of which the lien exists. **which the**
- 170. Subject to the provisions of the Act where any asset, business or property is bought by the Company as from a past date upon the terms that the Company shall as from that date take the profits and bear the losses thereof, such profits or losses, as the case may be, shall, at the discretion of the Directors, be credited or debited wholly or in part to revenue account, and in that case the amount so credited or debited shall, for the purpose of ascertaining the fund available for dividend, be treated as a profit or loss arising from the business of the Company and available for dividend accordingly. Subject as aforesaid, if any shares or securities are purchased cum dividend or interest, such dividend or interest when paid may at the discretion of the Directors be treated as revenue and it shall not be obligatory to capitalise the same or any part thereof.
- 171. The Directors may retain the dividends payable upon shares in respect of which any person is under the provisions as to the transmission of shares hereinbefore contained entitled to become a member, or which any person is under those provisions entitled to transfer, until such person shall become a member in respect of such shares or shall transfer the same.
- 172. All dividends unclaimed for more than one (1) year after having been **Un** declared may be dealt with in accordance with the provisions of the **Di** Unclaimed Monies Act, 1965.
- 173. Any dividend declared on Deposited Securities shall accrue to the Depositors whose names appear on the Record of Depositors issued to the Company or the Company's Registrar pursuant to the Rules.
- 174. Any dividend, interest or other money payable in cash in respect of shares may be paid by way of direct transfer by means of the electronic payment systems, upon terms and subject to conditions as the Directors may stipulate, or by cheque or warrant and sent through the post directed to the registered address of the holder, or to such person and to such address as the holder may in writing direct or, if several persons are entitled thereto in consequence of the death or bankruptcy of the holder, to any one of such persons or to such person and to such address as such persons may by writing direct, subject to the Rules. Every such cheque or warrant shall be made payable to the order of the person to whom it is sent, or to such person as the holder or person or persons entitled to the share in consequence of the death or bankruptcy of the holder may direct, and the payment of any such cheque or warrant shall operate as a good discharge to the Company in respect of the dividend represented thereby. Every such cheque or warrant shall be sent at the risk of the person entitled to the money thereby represented. No unpaid dividend or interest shall beat interest against the Company.

- 176. The Company may, upon the recommendation of the Directors, by ordinary resolution resolve, either unconditionally or subject to such conditions as it may deem fit, that it is desirable to capitalise any sum standing or which will stand to the credit of the profit and loss account, or otherwise available, or which will become available for distribution, provided that such sum be not required for paying the dividends on any shares carrying a fixed cumulative preferential dividend, and accordingly that the Directors be authorised to appropriate the sum resolved to be capitalised to the members holding ordinary shares in the proportions in which such sum would have been divisible amongst them had the same been applied or been applicable in paying dividends and to apply such sum; their behalf, either in or towards paying the amounts (if any) for the time being unpaid on any shares held by such members respectively, or paying up in full unissued shares or debentures of the Company, such shares or debentures to be allotted and distributed credited as fully paid up to and amongst such members in the proportion aforesaid or partly in one way and partly in the other.
- 177. Whenever such a resolution as aforesaid shall have been passed, the Directors shall make all appropriations and applications of the undivided profits resolved to be capitalised thereby, and all allotments and issues of fully paid shares or debentures, if any, and generally shall do all acts and things required to give effect thereto, with full power to the Directors to make such provision by the issue of fractional shares or by payment in cash or otherwise as they think fit for the case of shares or debentures becoming distributable in fractions, and also to authorize any person to enter on behalf of all the members entitled thereto into an agreement with the Company providing for the allotment to them respectively, credited as fully paid up, of any further shares or debentures to which they may be entitled upon such capitalisation, or (as the case may require) for the payment up by the Company on their behalf, by the application thereto of their respective proportions of the profits resolved to be capitalised of the amounts or any part of the amounts remaining unpaid on their existing shares, and any agreement made under such authority shall be effective and binding on all such members.

- 179. A copy of each such documents shall not less than twenty-one (21) clear days (or such other shorter period as may be agreed by all members entitled to attend and vote at the meeting) before the date of the meeting, be sent to every member of, and to every holder of debentures of the Company under the provisions of the Act or of this Constitution. The requisite number of copies of each such document as may be required by the Exchange and Securities Commission shall at the same time be likewise sent to the Exchange and Securities Commission provided that this Clause shall not require a copy of these documents to be sent to any person of whose address the Company is not aware, but any member to whom a copy of these documents has not been sent shall be entitled to receive a copy free of charge on application at the Office.

- 183. The Auditors shall be entitled to attend any general meeting and to **A** receive all notices of and other communications relating to any general **E** meeting which any member is entitled to receive, and to be heard at **A** any general meeting on any part of the business of the meeting which **N** concerns the Auditors.

LANGUAGE

184. Where any accounts, minute books or other records required to be kept **Language** by the Act, are not kept in Bahasa Malaysia or the English language, the Directors shall cause a true translation of such accounts, minute books and other records to be made from time to time at intervals of not more than seven (7) days, and shall cause such translation to be kept with the original accounts, minute books and other records for so long as the original accounts, minute books and other records are required by the Act to be kept.

DESTRUCTION OF RECORDS

- 185. All instruments of transfer, which shall have been registered at any Company May time, after a reasonable time from the date of registration thereof, and Destrov all share certificates and dividend mandates, which have been cancelled **Documents** or have ceased to have effect at any time after the expiration of one (1) year from the date of cancellation or cessation thereof, and all notifications of change of name or address after the expiration of one (1) year from the date they were recorded, and in favour of the Company, it shall conclusively be presumed that every entry in the register which purports to have been made on the basis of an instrument of transfer or other document so destroyed, was duly and properly made, and every share certificate so destroyed was a valid certificate duly and properly cancelled, and every other document hereinbefore mentioned so destroyed, was a valid and effective document in accordance with the recorded particulars thereof in the books or records of the Company provided that:
 - (a) the foregoing provisions of this Clause shall apply only to the destruction of a document in good faith and without express notice that the preservation of such document was relevant to a claim; and
 - (b) nothing contained in this Clause shall be construed as imposing upon the Company any liability in respect of the destruction of any such document earlier than as aforesaid or in any other circumstances which would not attach to the Company but for the provisions of this Constitution.

Any Director or the Secretary or any person appointed by the Directors **Appointed** for the purpose shall have power to authenticate any documents affecting the Constitution of the Company, and any resolution passed by the Company or the Directors, and any books, records, documents and accounts relating to the business of the Company, and to certify copies thereof, or extracts therefrom, as true copies or extracts; and where any books, records, documents or accounts are kept elsewhere other than in the Office, the local manager, or other officer of the Company having the custody thereof, shall be deemed to be a person appointed by the Directors as aforesaid. 187

A document purporting to be a copy of a resolution of the Directors or an extract from the minutes of a meeting of the Directors which is certified as such in accordance with the provisions of the last preceding Clause shall be conclusive evidence in favour of all persons dealing with the Company upon the faith thereof that such resolution has been duly passed or, as the case may be, that such extract is a true and accurate record of a duly constituted meeting of the Directors.

- 188. A notice or other document shall be served by the Company or the Mode of Secretary on any member or Director, as the case may be, either personally or by sending it through the post in prepaid letter addressed to such member or Director at his registered address or service address as appearing in the register of Directors and the Records of Depositors, as the case may be, in Malaysia or (if he has no address within Malaysia) to the address, if any, within Malaysia supplied by him to the Company for the giving of notices to him.
- 189. A notice or other document if served by post shall be deemed to be served three (3) days following that on which a properly stamped letter containing the same is posted. In proving service by post, it shall be sufficient to prove that the letter containing the notice or document was properly addressed and stamped and put into a Government post office letter box.
- 190. 190.1 A notice or other document may also be served by the Company or the Secretary on any Director or securities holder in hard copy, in electronic form or partly in hard copy and partly in electronic form. Notices given in hard copy shall be sent to the Director or securities holder personally or by post to the address supplied by the Director or securities holder for such purpose, or if given in electronic form, transmitting to the electronic address provided by the Director or securities holder for such purpose.

 - (b) pursuant to Clause 190.2(b), shall be deemed to have been served 2 days from the date the notification of publication of the notice or other document on the Company's website is given to the members; or
 - (c) pursuant to Clause 190.2(c), shall be deemed to have been served 2 days from the later of the time the notification of the making available of the notice and/or document on the relevant electronic platform is served or deemed served, as the case may be, and the time the notice or other document is first made available or accessible to members on the electronic platform.
- 190.5 In the event that service of a notice or other document pursuant to Clause 190.2 is unsuccessful, the Company must, within 2 market days of discovering the delivery failure, make alternative arrangements for service by serving the notice or document by hard copy in accordance with Clause 190.1.
- 190.6 The registered address in Malaysia (or if he has no address within Malaysia, to the address within Malaysia supplied by the member or the Director of the Company for giving of notices or other documents to him) and electronic mail address of the member and/or Director appearing in the Record of Depositors, Register of Members or Register of Directors, as the case may be, shall be deemed as the last known address for purposes of service of notices or documents to the member or Director, as the case may be, by the Company.
- 191. Every person who, by operation of law, transfer, transmission or other means whatsoever, shall become entitled to any share, shall be bound by every notice in respect of such share, which, previously to his name and address being entered in the Record of Depositors as the registered holder of such share, shall have been duly given to the person from whom he derives the title to such share, provided always that a person entitled to a share in consequence of the death or bankruptcy of a member, upon supplying to the Company such evidence as the Directors may reasonably require to show his title to the share, and

Person Entitled to Shares by Transfer, Transmission, Etc Bound by Notices upon supplying also an address within Malaysia for the service of notices, shall be entitled to have served upon him at such address any notice or document to which the member but for his death or bankruptcy would be entitled, and such service shall for all purposes be deemed a sufficient service of such notice or document on all persons interested (as claiming through or under him) in the share.

- 192. Subject always to the provisions of Clause 191, any notice or document in hard copy or electronic form or partly in hard copy and partly in electronic form delivered or sent by post to, or left at, the registered address or electronic address provided by any member shall, if such member be then deceased, and whether or not the Company has notice of his death, be deemed to have been duly served on his legal personal representatives.
- 193. (1) Notice of every general meeting shall be given in any manner **Persons** hereinbefore to: **Entitled**

Entitled to Notice of General Meeting

- (a) every member at his registered address as appearing in the Record of Depositors, as the case may be, in Malaysia, or (if he has no address within Malaysia) to the address, if any, within Malaysia supplied by him to the Company for the giving of notices to him;
- (b) to the electronic address provided by the member to the Company for such purpose, or by publishing on a website;
- (c) every person entitled to a share in consequence of the death or bankruptcy of a member who, but for his death or bankruptcy, would be entitled to receive notice of the meeting;
- (d) the auditor for the time being of the Company;
- (e) the Exchange; and
- (f) by way of advertisement in at least one (1) Bahasa Malaysia or English language daily newspaper with nationwide circulation.
- (2) Save as otherwise provided in this Constitution or in the Act, no other person shall be entitled to receive notice of general meetings.
- (3) Any notice on behalf of the Company or of the Board shall be deemed effectual if it purports to bear the signature of the Secretary or other duly authorised officer of the Company.

WINDING UP

194. If the Company is wound up (whether the liquidation is voluntary, **Distribution in** under supervision, or by the Court), the liquidator may, with the sanction of a special resolution of the Company, divide amongst the members in specie or in kind the whole or any part of the assets of the Company (whether they consist of property of the same kind or not) and may for that purpose set such value as he deems fair upon any property to be divided as aforesaid and may determine how the division shall be carried out as between the members or different classes of members. The liquidator may, with the like sanction, vest the whole or any part of any such assets, in trustees upon such trusts for the benefit of the contributories as the liquidator, with the like sanction, thinks fit, but so that no member shall be compelled to accept any shares or other securities whereon there is any liability.

- 195. Save that this Clause shall be without prejudice to the rights of holders **Distribution of** of shares issued upon special terms and conditions, the following **Assets** provisions shall apply:
 - (a) If the Company shall be wound up and the assets available for distribution among the members as such shall be insufficient to repay the whole of the paid up capital, such assets shall be distributed so that as nearly as may be the losses shall be borne by the members in proportion to the capital paid up, or which ought to have been paid up at the commencement of the winding-up, on the shares held by them respectively.
 - (b) If in a winding-up the assets available for distribution among the members shall be more than sufficient to repay the whole of the capital paid up at the commencement of the winding-up, the excess shall be distributed among the members in proportion to the capital paid up, or which ought to have been paid up at the commencement of the winding up, on the shares held by them respectively.
- 196. On a voluntary winding up of the Company, no commission or fee shall **Commission or** be paid to a liquidator without the prior approval of the members in **Fee to** general meeting. The amount of such commission or fee shall be **Liquidators** notified to all members not less than seven (7) days before the meeting at which it is to be considered.

SECRECY CLAUSE

197. Save as may be provided by the Act, no member shall be entitled to **Secrecy** enter into or upon or inspect any premises or property of the Company nor to require discovery of any information respecting any detail of the Company's trading, manufacturing or any matter which is or may be in the nature of a trade secret or secret process which may relate to the conduct of the business of the Company and which in the opinion of the Directors, it would be inexpedient in the interest of the members of the Company to communicate to the public.

INDEMNITY

198. Subject to the provisions of the Act, every Director, Managing Director, In Deputy Managing Director, Assistant Managing Director, agent, auditor, In Secretary and other officer for the time being of the Company shall be indemnified out of the assets of the Company against any liability D incurred by him in defending any proceedings, whether civil or criminal, S in which judgement is given in his favour or in which he is acquitted or in connection with any application under the Act in which relief is granted to him by the Court in respect of any negligence, default, breach of duty or breach of trust.

Indemnity to the Directors, Managing Director, Secretary, Etc

RECONSTRUCTION

199. On the sale of the undertaking of the Company, the Directors or the *Reconstruction* liquidators on a winding up may, if authorised by a special resolution, accept fully paid or partly paid-up shares, debentures or securities of any other company, either then existing or to be formed for the purchase in whole or in part of the property of the Company, and the Directors (if the profits of the Company permit), or the liquidators (on-a winding up), may distribute such shares or securities, or any property of the Company amongst the members without realisation, or vest the same in trust for them, and any special resolution may provide for the distribution or appropriation of the cash, shares or other securities, benefits or property, otherwise than in accordance with the strict legal rights of the members or contributories of the Company, and for valuation of any such securities or property at such price and in such manner as the meeting may approve, and all holders of shares shall be bound to accept and shall be bound by any valuation or distribution so authorised, and waive all rights in relation thereto, save only in the case of the Company which is proposed to be or is in the course of being wound up, such statutory rights (if any) under the Act as are incapable of being varied or excluded by these Clauses.

EFFECT OF LISTING REQUIREMENTS

- 200. (1) Notwithstanding anything contained in this Constitution, if the Listing *Effect of Listing* Requirements prohibit an act being done, the act shall not be done. *Requirements*
 - (2) Nothing contained in this Constitution prevents an act being done that the Listing Requirements require to be done.
 - (3) If the Listing Requirements require an act to be done or not to be done, authority is given for that act to be done or not to be done (as the case may be).
 - (4) If the Listing Requirements require this Constitution to contain a provision and they do not contain such a provision, this Constitution are deemed to contain that provision.
 - (5) If the Listing Requirements require this Constitution not to contain a provision and they contain such a provision, this Constitution are deemed not to contain that provision.
 - (6) If any provision of this Constitution is or becomes inconsistent with the Listing Requirements, these Clauses are deemed not to contain that provision to the extent of the inconsistency.

THE ACT, CENTRAL DEPOSITORIES ACT AND THE RULES

201. Notwithstanding this Constitution, the Company shall comply with the Comp Act, Central Depositories Act, the Listing Requirements and the Rules in with the respect of all matters relating to Securities or otherwise, where Central applicable. Depositories
