

The company recently introduced a new coating green technology called NRXTM Coating System which utilises rust conversion primer, water borne and surface tolerant. NRXTM coating requires minimum surface preparation and provides excellent corrosion protection whilst reducing the cost of coating application.

LONG TERM SERVICE AGREEMENT (LTSA)

UPDATES: LONG TERM SERVICE AGREEMENT

- Turboservices Sdn. Bhd. had in FY2013 received a Letter of Award from Petroliam Nasional Berhad to provide aftermarket turbomachinery maintenance services for Solar Turbines Incorporated's gas turbines in Malaysia.
- The tenure of the LTSA is for 7 years since 2013 which ended in September 2020 whereby an extension of one more year till September 2021 has been secured.
- The scope of work in regards to the LTSA consists of supply of serviced parts, overhaul and exchange engine services, field service support, training, machinery renewal and upgrade work as well as project management.
- Covering approximately 300 gas turbine packages in the range of 1-18MW with 85% market share.
- Turbine maintenance is required for every 4,000 hours. Major overhaul is needed between 25,000 to 30,000 hours.





QUARTERLY RESULTS



TOP LINE ANALYSIS

Q2FY2020 revenue decreased by RM73.4 million or 34.6% as compared to Q2FY2019.

P&M: ♦ RM9.0 mil (♦ 9.4%)	Due to lower revenue contribution from exchange engines sales, retrofit projects, absence of commission income, lower supply of local field service representative, decline in third party services mitigated by stronger sales recorded for turbine parts, valves and flow regulators services.
OS: ▼ RM16.1 mil (▼ 40.3%)	Due to decline in activity level for well intervention and enhancement services, slickline activities and lower chemical sales mitigated by higher sales from gas lift valve services.







Segment Revenue Composition Cumulative Q2FY2020




Segment Revenue Composition Cumulative Q2FY2019





ORDER BOOK AS AT 30 JUNE 2020



KUALA LUMPUR: MALAYSIA'S oil and gas (0&G) firms are expected to face fiercer competition in the long term even as they improve on cost efficiency to remain resilient, said analysts.

Kenanga Investment Bank Bhd said O&G service players were facing limited tenders while having to deal with tighter cash flows, unutilised vessels and ballooning debt obligations.

"While we believe the industry is undergoing restructuring, which allows the fittest to survive, we observe that some players have collaborated to tender for jobs far beyond their core competence.

"Thus, we expect more bidders for the very same job, with some quoting significant lower prices in order to bag the contract. Oil majors are also more inclined to dish out contracts on a lump sum basis instead of on a per vessel basis, pushing the cost management obligation towards services players," it said in a research note recently.
