NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED INTERIM FINANCIAL STATEMENTS

PART 1-Explanatory Notes Pursuant to MFRS 134

A1. Turbo-Mech Berhad is a public limited liability company incorporated and domiciled in Malaysia, and is listed on Bursa Malaysia Securities Berhad.

These condensed consolidated interim financial statements were approved by Board of Directors on 27 May 2019.

The Group achieved revenue of RM7.9 million for the current quarter, an increase of RM3 million compared to the RM4.9 million achieved during the preceding year corresponding quarter. The increase in revenue was mainly due to general increase in sales activities across the region.

The Group achieved gross profit of RM1.9 million during the current quarter compared with preceding year corresponding quarter. The gross profit margin for this quarter is 24.2% which is lower than the gross profit margin of 39.4% achieved during the preceding year corresponding quarter due to change in product mix.

For the current quarter, the Group recorded a loss after tax of RM0.78 million, compared against the preceding year corresponding quarter loss after tax of RM1.2 million. The decrease in loss was mainly due to higher contribution from associates and reduction in operating expenditure.
