NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED INTERIM FINANCIAL STATEMENTS

PART A – Explanatory Notes Pursuant to MFRS 134

A1. Turbo-Mech Berhad is a public limited liability company incorporated and domiciled in Malaysia, and is listed on Bursa Malaysia Securities Berhad ("Bursa Securities").

These condensed consolidated interim financial statements were approved by Board of Directors on 22 May 2023.

A2. Basis of preparation

The condensed consolidated interim financial statements of the Group for the first quarter ended 31 March 2023, have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134 *Interim Financial Reporting* issued by Malaysian Accounting Standards Board and paragraph 9.22 of the Main Market Listing Requirements of Bursa Securities. These condensed consolidated interim financial statements also comply with IAS 34 Interim Financial Reporting issued by the International Accounting Standards Board.

The condensed consolidated interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2022.

The explanatory notes attached to these condensed consolidated interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2022.

A3. Changes in accounting policies

The significant accounting policies and methods of computation adopted for the condensed consolidated interim financial statements are consistent with those of the audited financial statements for the year ended 31 December 2022 except for the adoption of the following new or revised MFRSs.

Standards and interpretations that are issued but not yet effective

The standards and interpretations that are issued but not yet effective as of the date of issuance of these interim financial statements are disclosed below. The Group and the Company intend to adopt these standards and interpretations, if applicable, when they become effective.

The audited financial statements of the Group for the financial year ended 31 December 2022 was not subject to any qualification.

The business operations of the Group are affected by the cycles of capital and repairs/maintenance programs implemented by major players in the oil, gas, and petrochemical sector.

A6. Unusual items due to nature of size or incidence

There were no unusual items affecting assets, liabilities, equity, net income, or cashflows of the Group during the financial quarter under review.

A7. Change in estimates

There were no changes in estimates that have had material effect on the results of the financial quarter under review.

The valuation of property, plant and equipment has been brought forward without amendment from the audited financial statements as at 31 December 2022.

The Group recorded revenue of RM7.5 million for the current quarter, a decrease of RM3.4 million or approximately 32% from the revenue recorded during the preceding year corresponding quarter of RM10.9 million. The decrease in revenue was mainly due to general decrease in sales activities in Singapore.

The Group registered a higher gross profit of RM4.1 million during the current quarter as compared with RM2.9 million registered in preceding year corresponding quarter. The gross profit margin for this quarter of 54.5% is higher than the gross profit margin of 26.8% achieved during the preceding year corresponding quarter. The reason for this is the shift in the assortment of products and a generally higher selling price of products in the Singapore division.

During the current quarter, the Group's profit after tax was RM0.85 million, which represents an increase of RM0.81 million or 1978% from RM0.04 million registered for the corresponding quarter of the preceding year. The main reason for this was the increase in gross profit margin that was achieved during the quarter.

The Group recorded revenue of RM7.5 million for the current quarter, a decrease of RM7.2 million or 49% from the revenue recorded for the immediate preceding quarter of RM14.7 million. The decline is primarily attributed to cyclical factors, as sales performance gradually improved and gained momentum towards the end of the year.

The Group recorded a profit before tax of RM1.25 million during the current quarter, compared to the profit before tax of RM0.9 million registered for the immediate preceding quarter. The increase was mainly attributable to the increase in gross profit margin that was achieved during the quarter.

For the current quarter, the Group recorded a profit after tax of RM0.85 million, compared against the previous quarter profit after tax of RM0.3 million.



B3. Prospects

The market sentiments remain challenging due to the uncertainties arising from the current global economic and political headwinds.

As a supplier of equipment and instruments to both upstream and downstream segments of the petrochemical industries, the demand for our products and services is determined by the demand for petrochemical industries products which is influenced by the market and economic conditions.

The Group does not foresee any significant change in clients' business plan in the short and medium terms, thus it is expected that margin pressure from clients will continue. Nevertheless, the Group will continue to focus on maintenance and services and will stay relevant in the industry.

The Group did not issue any profit forecast or profit guarantee for the current financial quarter under review.

The effective tax rate of the Group for the current quarter of 31.9% exceeds the statutory tax rate of 24% primarily because of the rise in non-deductible expenses and increase in contributions from countries with higher tax regimes.
