PART A - EXPLANATORY NOTES PURSUANT TO MFRS 134

1. First-time Adoption of Malaysian Financial Reporting Standards ("MFRS")

These condensed consolidated interim financial statements, for the year ended 31 January 2013, have been prepared in accordance with *MFRS134: Interim Financial Reporting* and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. These condensed consolidated interim financial statements also comply with *IAS34: Interim Financial Reporting* issued by the International Accounting Standards Board ("IASB"). For the periods up to and including the year ended 31 January 2013, the Group prepared its financial statements in accordance with the Financial Reporting Standards ("FRS").

These condensed consolidated interim financial statements are the Group's first MFRS condensed consolidated interim financial statements for part of the period covered by the Group's first MFRS annual financial statements for the year ending 31 January 2013. *MFRS 1: First-Time Adoption of Malaysian Financial Reporting Standards ("MFRS1")* has been applied.

The date of transition to the MFRS framework is 1 February 2012. At that transition date, the Group reviewed its accounting policies and considered the transitional opportunities under MFRS 1. The impact of the transition from FRS to MFRS is described in Note 2 below.

2. Significant Accounting Policies

Application of MFRS 1

The audited financial statements of the Group for the year ended 31 January 2012 were prepared in accordance with FRS. Except for certain differences, the requirements under FRS and MFRS are similar. The significant accounting policies adopted in preparing these condensed consolidated interim financial statements are consistent with those of the audited financial statements for the year ended 31 January 2012 except as discussed below:

a) Definition of Cash and Cash Equivalents

Under FRS, the Group defined all its cash on hand and at banks and short term deposits as cash and cash equivalents where they are readily convertible to known amount of cash and are subject to insignificant risk of changes in value.

Upon transition to MFRS, the Group redefined its cash and cash equivalents to mean cash on hand and at banks and short term deposits for purposes of meeting short term funding requirements. The comparative information for the relevant periods in the condensed consolidated statements of cash flow has been restated accordingly.

c) Under FRS, the Group recognised translation differences on foreign operations as a separate component of equity. Cumulative foreign currency translation differences for all foreign operations are deemed to be nil as at the date of transition to MFRS.

Accordingly, at the date of transition to MFRS, the cumulative foreign currency translation differences of RM1,737,000 (31 January 2012: RM1,737,000; 31 January 2012: RM1,737,000) were adjusted to retained earnings.

The reconciliations of equity and total comprehensive income for comparative periods and of equity at the date of transition reported under FRS to those reported for those periods and at the date of transition under MFRS are provided below:

d) Amendment to MFRS 112

The amendment clarified the determination of deferred tax on investment property measured at fair value. The amendment introduces a rebuttable prescription that deferred tax on investment property measured using the fair value model in MFRS 140 should be determined on the basis that the carrying amount will be recovered through sale. Furthermore, it introduces the requirements that deferred tax on non-depreciating assets that are measured using the revaluation model in MFRS 116 to be always measured on the sale basis of that asset.

3. Seasonal or Cyclical Factors

The Group's transport operations are generally affected by major festivals that occur in the first and third quarter of the financial year as there were fewer working days.

4. Unusual Items due to their Nature, Size or Incidence

There were no unusual items affecting assets, liabilities, equity, net income or cash flows during the current quarter and financial year to-date.

5. Changes in Accounting Estimate

There were no material changes in accounting estimates that have a material effect in the current quarter and financial year-to-date results.

6. Changes in the Composition of the Group

i) Yen Son Diversified

On 5 April 2012, the company wholly-owned subsidiary, Yinson Vietnam Company Limited, acquired a 49% stake at a value equivalent to RM431,591 in Yen Son Diversified Company Limited ("Yen Son Diversified") with a chartered (paid-up) share capital of VND6,000,000,000 equivalent to RM880,799. On 8 November 2012, it acquired a further 2% stake and increased its shareholding in the charter (paid-up) share capital of Yen Son Diversified to 51%. Yen Son Diversified was incorporated on 30 December 2010 and its principal activity shall be the provision of warehousing facilities at PTSC Phu My Port in Vung Tau, Vietnam. Yen Son Diversified has not commenced operation.

ii) Yinson Hibiscus Limited

On 25 July 2012, the Company announced it had incorporated a Labuan offshore company under the name of Yinson Hibiscus Limited ("YHL") with a paid-up share capital of US\$10,000. The principal activity of YHL shall be the provision of leasing of vessel on a bare-boat basis. YHL has not commenced operation.

The Group is organized into business units based on their product and services, and has four operating segments as follows:

- (a) The transport segment consists of the provision of trucking services.
- (b) The marine segment consists of leasing of vessels, provision of barge services and marine management services.
- (c) The trading segment consists of trading activities mainly in the construction related materials.
- (d) Other operations consist of provision of warehouses, rental from investment properties and investment income.

Except for the purchase of a vessel amounting to RM91.4 million, there has been no material change in total assets and no differences in the basis of segmentation or in the basis of measurement of segment profit or loss as compared to the last annual financial statements.

Transport

Revenue from transport segment for the financial year ended 31 January 2013 increased by RM20.295 million or 23% to RM110.160 million compared with RM89.865 million for preceding year corresponding period due to increase in demand for the Group's transportation services. The increase in revenue led to better utilisation and return on the assets which resulted in an increase in earnings before interest and taxation by RM2.221 million to RM9.077 million compared to RM6.856 million for the preceding year corresponding year.

<u>Marine</u>

Revenue from marine segment for the financial year ended 31January 2013 was RM70.423 million compared with RM58.780 million for the preceding year, an increase of RM11.643 million. The increase in revenue was mainly due to the acquisition of a new vessel during the current year and contribution from full operations of new vessel acquired during the previous financial year. The increase in revenue resulted in an increase in profit before interest and taxation by RM11.194 million to RM23.708 million compared to RM12.514 for the preceding year corresponding period.

Trading

Revenue from trading segment for the financial year ended 31 January 2013 was RM681.372 million compared with RM566.305 million, an increase of RM115.067 million or 20% due to increase in demand. The increase in revenue resulted in an increase in profit before interest and taxation by RM5.444 million or 24% to RM28.378 million compared to RM22.934 million for the preceding year corresponding period.

Other Operations

The profit before interest and taxation for current year for other operations was RM2.220 million compared to profit before interest and taxation of RM1.697 million for the preceding year corresponding period. Included in other operations current year results are gain from fair value adjustment for investment in associate of RM3.051 million, exchange loss of RM2.179 million and shares issuance expenses of RM0.314 million incurred for rights issue whilst results for the preceding year consist of gain of RM1.204 million on disposal of a subsidiary, fair value gain of RM0.462 million from reclassification of property, plant and equipment to investment property and gain of RM1.999 million from disposal of properties.

Consolidated profit before taxation

For the financial year ended 31 January 2013, the Group's revenue increased by RM147.092 million or 21 percent to RM862.916 million compared to RM715.824 million for the preceding year corresponding period mainly attributable to increase in volume of sales from transport, trading and marine transport businesses.

The Group's profit before taxation for the financial year ended 31 January 2013 increased by RM12.672 million or 39 percent to RM45.441 million as compared to RM32.769 million for the preceding year mainly attributable to increase in revenue and contribution from trucking, trading and marine transport businesses and net gain from fair value adjustment of investment in associate of RM3.015 million despite an increase in allowance for receivables of RM7.2 million and exchange loss of RM1.6 million.

11. Property, plant and equipment

Acquisitions and disposals

During the twelve months ended 31 January 2013, the Group acquired assets at a cost of RM97.543 million (31 January 2012: RM52.312 million).

Assets with a carrying amount of RM1.124 million were disposed by the Group during the twelve months ended 31 January 2013 (31 January 2012: RM2.533 million), resulting in a gain on disposal of RM0.057 million (31 January 2012: RM2.200 million), recognised and included in other operating income.

21. Material Changes in the Profit Before Taxation of Current Quarter Compared with Preceding Quarter

The Group's net profit before taxation for the current quarter ended 31 January 2013 decreased by RM4.482 million to RM7.000 million compared to RM11.482 million for the preceding quarter ended 31 October 2012 mainly due to decrease in contribution from marine segment as a result of drop in revenue, increase in allowance for receivables of RM7.9 million, increase in exchange loss of RM2.488 million and offset by better contribution from trading segment due to improve margin and a net gain of RM3.015 million from fair value adjustment of investment in associate.

22. Commentary on Prospects

The Malaysian economy is expected to grow at 5.6% in 2013 and going forward there are emerging signs of improvements in the global economy. The oil and gas industry is slated for sustained growth.

With the coming on-stream of the FSO operations, the Group expects its performance for the next financial year to be better than the current financial year.
